## THINGS TO KNOW

#### FREE MEMBERSHIP

As a student in an accredited Canadian planning program, you will receive free membership with CIP up until your graduation date.

#### PLANNING PRIORITIES

In recent years, CIP has been focusing its work on five key policy priorities: Equity, Diversity, & Inclusion (EDI), Truth & Reconciliation, Climate Change, Healthy Communities, and Housing. As a result, CIP has developed the *Equity, Diversity and Inclusion Roadmap* and three national policies to guide planners' work on Climate Change Planning, Healthy Communities, and Planning Practice and Reconciliation. These priorities are also reflected in our brand-new Strategic Plan: *1,835 Days of Impact*. With this plan, CIP reaffirms its support of inclusive and vibrant communities, respectfully connected to the natural world, for the well-being of current and future generations.

#### **VOLUNTEERING & NETWORKING**

As a student member of CIP, you have access to *volunteer opportunities* to get involved in national committees and juries, as well as to represent CIP on external projects and organizations. CIP also has two LinkedIn groups that members may join — *general* and *international* planning — that provide additional networking, volunteering, and learning opportunities.

## THINGS TO KNOW

#### **GOVERNANCE & TRANSPARENCY**

CIP is a not-for-profit organization, governed by a 13-member *Board of Directors* (including one student). Following each Board meeting, a summary is emailed to members through the Board Bulletin. *Annual Reports* can also be found online, which include key accomplishments and audited financial statements. All members are welcome to attend CIP's Annual General Meeting, normally held at the national planning conference.

### RESOURCES

#### SCHOLARSHIPS AND BURSARIES

Each year, the *CIP/ICU Planning Student Trust Fund (CIP-PSTF)* offers scholarships and bursaries to CIP student members who are enrolled full-time in accredited Canadian planning programs. In Canada, programs are accredited by the Professional Standards Board for the Planning Profession in Canada (PSB) and l'Ordre des urbanistes du Québec (*OUQ*). Published every quarter, and available to students for free in digital format, the magazine features informative articles on innovative projects and research in Canadian planning. Members are always encouraged to *contribute to the magazine* and are provided information on *upcoming issues* and themes in advance.

#### CANADIAN PLANNING AND POLICY JOURNAL

The profession's scholarly publication project, undertaken by CIP and the Association of Canadian University Planning Programs, is an open-access, digital, bilingual, peer-reviewed journal with a double-blind review process run by an editorial team of distinguished scholars. *Canadian Planning and Policy* regularly publishes manuscripts reflecting the scope and diversity of planning theory and practice in Canada.

#### CAREERS IN PLANNING

CIP's national job board, *Careers in Planning*, is a repository of job postings for all career levels — from senior level planning positions to student internships. Members can also sign up for new job alerts, post their résumés, and access the *National Compensation and Benefits Survey*.

#### NATIONAL CONFERENCE

Student members receive a discounted rate for *CIP's annual national planning conferences*, bringing planners together from across the country — and the world — to learn and network with one another. Students may participate in sessions, workshops and learning tours and attend networking events, including our Meet & Mentor (which connects students and young professionals with Senior Planners and Fellows of the Institute). Volunteer opportunities are available to students in exchange for additional registration fee discounts.

CIP's *CPL Webinar Program* provides our student members year-round learning opportunities at no cost. Covering a wide range of topics, these live broadcasts feature new and progressive perspectives on current and emerging planning issues.
